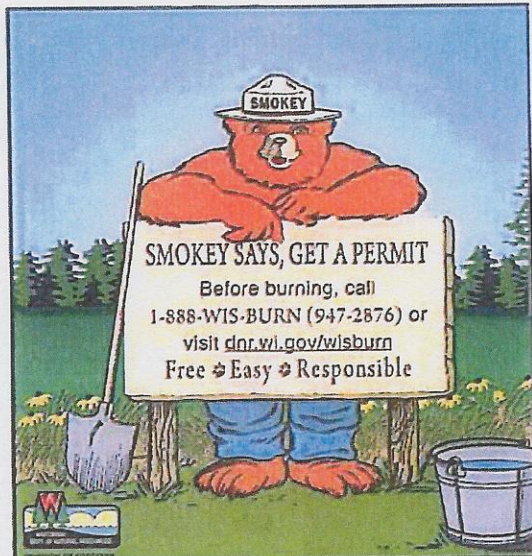


Where can I get a burning permit and find out the burning restrictions for the day?
